



STUDENT VISA GUIDE FOR ARGENTINA

If you have a **U.S. passport** and your ASA program is more than 90 days in length (e.g., a Semester) you **MUST** obtain your visa **BEFORE** departure.

TWO OPTIONS TO APPLY FOR THE VISA:

👉 **Option A: Consulate Application.** Apply for a **“Student Visa -365”** at the consulate corresponding to your permanent U.S. address. (Check your [🔗 Consular Office jurisdiction](#))

- → *Requires mailing your physical passport and other visa documents, paying the fees, and attending an in-person interview.*

👉 **Option B: Online Application.** Apply for a **“TIE”** Tramitación de Ingreso Electrónico.




- → *100% remote application process, requires completing online forms, paying the fees, and uploading the visa documents.*

Visa Documentation Checklist for Argentina

REQUIRED DOCUMENTS






1) Documents You Must Gather

-  **Valid Passport:** Must have at least **six (6) months of validity** remaining from your date of entry into Argentina and include at least **two (2) blank pages**.
-  **Passport Photos:** Two (2) recent 4x4 cm photographs. These must be front-facing, printed in color, and taken against a plain white background.
-  **Proof of Financial Means:** To demonstrate you can support yourself during your stay, you must provide:
 - **Bank Statements:** Copies of the last **three (3) months** of statements (these can be your own or from a parent/guardian).

 **NOTE:** For programs lasting less than six months (one semester), an FBI Background Check and Federal Apostille are NOT required.

2) Documents ASA Will Provide

These will be sent to you via email a few weeks after you have been accepted:

-  **Universidad de Belgrano Acceptance Letter:** A letter from the host institution showing the length of the academic term.
-  **Program of Study:** An outline of your academic enrollment.
-  **“Pre-Carga de Datos en Migraciones”:** Official proof that your data as an international student has been registered with Argentine Immigration (Migraciones).
-  **“RENURE certificate”:** You only need this if you do the Consular Application.
-  **ASA Accommodation & Tuition Letter:** As a complement to “proof of financial means”. This letter confirms that your housing and tuition costs are fully covered by the program.



⚠ IMPORTANT REMINDERS

- **Timeline:** ASA will email your required documents some weeks after acceptance into the program. In the meantime, you can work on getting the documents you need to gather on your own.
- **When to apply:** Ideally, you should apply for the visa two months before departure. If you have less time, the TIE (Option B) is usually the fastest.
- **FBI Background Check NOT required** for students staying less than 6 months.
- **Spam Alert:** Monitor your **spam/junk folder** regularly. Official emails from Argentine Immigration (*Migraciones*) are often flagged as spam. Ensure you do not miss any time-sensitive payment links or approval notices.
- **Stay Informed:** Verify requirements at the [Argentine Consulate website](#) and [TIE website](#)
- **Upload your visa to your Embark account.**
